## **Supporting Affidavit for Issuance of Arrest Warrant**

I, Sergeant Mary G. Bonilla, being duly sworn, do depose and say:

That I have been employed by the Department of Safety, Division of State Police since October of 2003. I have attended the New Hampshire Police Academy and graduated in March of 2004. I worked in a patrol capacity for approximately four years and was then assigned to the detective division at Troop D. I was then assigned to the Major Crime Unit in 2011 for approximately four years and now currently hold the position of Detective Sergeant at Troop D. I have also worked in the prosecution unit for Troop D. I have attended classes on criminal investigation, drafting of search warrants, interview and interrogation, homicide investigation, and collection of evidence.

The information set forth below is based upon my personal involvement in the investigation into the homicide of Pamela Ferriere at the Dartmouth Hitchcock Medical Center Intensive Care Unit in Lebanon, NH, on September 12, 2017, as well as discussions with other members of law enforcement in that investigation.

- 1. On September 12, 2017, at approximately 1:24 p.m., the Lebanon Police Department received a 911 call from Lauren Wojtonik (age 23), a nurse at the Dartmouth Hitchcock Medical Center, reporting that a male visitor had pulled out a black handgun. Upon seeing the handgun, Lauren ran and took shelter in a different room. She then heard two gunshots followed by screams.
- 2. The victim has been identified as Pamela Ferriere (age 70). Ferriere was a patient in the ICU. Ferriere had suffered an aneurism and was in the intensive care unit but was due to be discharged from the hospital on Friday, September 15, 2017.
- 3. Today, September 12, 2017, Travis Frink (age 48) identified as Ferriere's son, arrived at the hospital to visit his mother. Frink had visited Ferriere earlier in her hospital stay as well.
- 4. Frink signed in at the visitor's desk at approximately 1:15 p.m. and then proceeded to the intensive care unit on the fourth floor.
- 5. Robert Ferriere, Pamela Ferriere's husband and Frink's step-father, was in the room when Frink arrived. Frink asked Robert Ferriere if he could have some time alone with his mom. Robert Ferriere asked Pamela Ferriere if that was okay and she indicated yes. Robert Ferriere exited the room, and as he turned out of the room he heard Pamela Ferriere shout or scream something. Robert Ferriere turned and looked into the room and saw Frink pointing a gun at Pam and fire several shots. Frink did

- not say a word. Frink put the gun in a bag he had been holding and walked by Robert Ferriere without saying a word. Robert Ferriere then called for help.
- 6. Lauren Wojtonik informed the police that she had been Pamela Ferriere's nurse for the past two weeks. Today Pamela had three visitors. Lauren overheard Robert say that Travis was coming over. Lauren said that Travis came into the room holding a small duffle bag. She turned and saw Travis holding a black handgun with both hands. Travis was pointing the gun at his mother, Pamela. Lauren then ran from the room and hid behind medical equipment. Lauren then heard two gun shots.
- 7. At approximately 5:20 p.m., Troopers Kelly Wardner and William Bright of the New Hampshire State Police spoke with Travis Frink. Frink was advised of his *Miranda* rights and elected to waive them. He admitted that he went to Dartmouth-Hitchcock today to kill his mother, and shot her several times in her hospital room. He drove up from Rhode Island to the hospital today.
- 8. Based on the foregoing, there is probable cause to believe that Travis Frink committed the crime of first-degree murder (one count) contrary to RSA 630:1-a, by purposely causing the death of Pamela Ferriere by shooting her.
